With due respect and reference to the above cited subject, I would like to state that on the day of 4<sup>th</sup> August, 2023 at around 2 AM my residence of Spring Villa, Phaippijang (under Patta No. 255 (New): Dag No. 1392, Village No. 91- Meitei Langol), Langol Housing Complex, Lamphelpat Sub-Division Imphal West, Manipur-795004 was openly looted and damaged by unknown miscreants taking advantage of the recent ongoing Communal Riot that started on the night of 3<sup>rd</sup> May, 2023 as I left my residence fearing for my life.
