**Subject :- Report on Looting and burning down of household items/assets, and discrimination of Schedule Tribes.**

Sir,

With reference to the above cited subject I have the honour to report to you as follows :

1. That I, **T.Ginlianmang** aged about 41 years S/O (L) **T.Ginkhosoi** belonging to the **Zou Tribe / Community**, a schedule Tribe recognized under the constitution of India , by virtue of which I am being entitled to the protection under **The SC/ST (Prevention of Atrocities) Act, 1989**, and that I am a Permanent Resident of **YaiphaLeikai House No. 35A. P.O., &P.S., Lamphel. Imphal-West District, Manipur.**
2. That at about 8:30 pm on the **3<sup>rd</sup> May 2023**, due to the ethnic violence in the state , I and my family have to run for our lives leaving behind our house along with all our household items and belongings. and took shelter at **143 Bn CRPF Camp**. And in the process some unknown miscreants Suspected to be members of Arambai Tengol have looted then burnt down our house, including all our Household items and belongings.
3. That, it may be reported here that the above said criminal activities have caused grave mental agony and incurred huge loss which may be estimated to be **Rs.60,00,000-/( Rupees Sixty Lakhs) only**
4. Fortunately, my family and I managed to escaped from the Violence, and now currently taking refuge at **Tuaitengphai Village, Churachandpur .**
5. That, I am filing this information lately because I was at different place And thus, I am filing the report lately today.

In the given circumstances, I humbly pray you kindly register an **FIR/ZERO FIR**, investigate the matter and punish the perpetrators as per the prevailing provisions of the laws of our country. And , for which act of kindness, I shall always remain thankful to you and obliged.
