Subject: FIR/Report for vandalism and looting of rooms and properties

Sir,

I, Ginkhansiam Guite, a 5th Semester B.Tech Computer Science and Engineering student at the National Institute of Technology, Manipur, a resident of Churachandpur, Manipur, am writing to bring to your attention an incident of vandalism and looting in my hostel room, Room No. A6:

Place of occurrence: Boys' Hostel No. 2, National Institute of Technology, Manipur, Langol, Imphal West, Imphal, Manipur-795004.

On the night of May 3, 2023, at around 8:00 PM, due to escalating violence in and around Langol, Imphal, I left my hostel and took refuge at 1st Manipur Rifle Ground, Imphal and haven't been able to return since due to prevailing law and order situation. Before leaving the campus, I responsibly secured my room by locking both my locker and door and obtained permission from the hostel warden, Dr. Sunil Pandey.

On December 10, 2023 at around 3:30 PM during a video call with a fellow hosteller at NIT Manipur who was assisting in packing my belongings after getting prior permission from the hostel warden, we discovered that my room had already been vandalized and looted by unknown miscreants highly suspected to be the people staying in the campus itself. The windows were opened. My locked locker had been forcefully opened, clothes were scattered and soiled, and a number of my possessions: 1) Casio fx-911EX Calculator 2) Sandisk pendrive 3) Audio Technica Headphone 4) Washburn electric guitar and accessories 5) Clothes: Sweaters, Jackets, Shirts, Pants and Socks 5) Around ₹3,000 of cash and other personal items were missing. A preliminary assessment of the looted items indicates a collective loss of approximately ₹25,000. I was assured by hostel authorities that my room was locked and secure and that, no mob violence had occurred in the campus up until this discovery.

I hereby request your immediate intervention and kindly seek your cooperation in registering an FIR under the relevant sections of the Indian Penal Code against the perpetrators involved in this heinous act of vandalism and theft. I trust that the Churachandpur Police and Lamphel Police, Imphal West, Manipur-795004 will undertake a thorough investigation to bring those responsible to justice.
