Subsequently the said rented house was fired by some unknown miscreants in that my two wheeler Honda Activa 125 Disc black in color bearing Regd. No. MN06SH-5421 having Chassis No. ME4JK132APW085666 and Engine No. JK13EW1124570 along with its keys and other relevant documents/vehicle's manual book were also included in the fire. The value of the said vehicle is worth Rs. 1,100,00/- (one lakh the thousand).

It is therefore, requested to kindly take up necessary legal action against culprits.


