Subject: FIR Application for Looting and Unauthorized Occupancy of my house

Dear Sir/Madam,

I am writing to file an FIR regarding the looting and unauthorized occupancy of my house at around 9:00 P.M. located at 1st Street New Lambulane, Imphal East, Imphal viz. Patta No. 1063, Dag No. 5414/5592 on 18-02-2024. I discovered that my house had been broken and several valuable items, including electronics, kitchen items were stolen by unknown miscreants. The perpetrators also vandalized the property and caused extensive damage to the interior.

U/S 427/380/456/447/448/341 PC.

Furthermore, I have reason to believe that the individuals responsible for the burglary have taken up unauthorized occupancy of my house. They have changed the locks and are claiming ownership of the property, despite having no legal right to do so.

Above all, I would like to add that due to ethnic cleansing, the unrest Imphal Valley and life threatening situations for the brethren of Kuki-Zo-Hmar peoples on 3rd May, 2023. Alongwith my family, we voluntarily moved to 1st MR Battalion, Old Lambulane on 9th May, 2023 for the safety of our lives and on 11th May 2023 with security cover from Indian Army we headed to Imphal Airport for Guwahati.

With all this, I request that you take immediate action to investigate this matter and particularly apprehend the culprits involved in the looting and unauthorized occupancy of my house. I urge you to expedite the investigation and take the necessary steps to ensure the safety and security of my property.

Thank you for your prompt attention to this matter. I look forward to a swift resolution of this issue.
