Alongwith my family, we voluntarily moved to 1st MR Battalion, Old Lambulane on 9th May, 2023 for the safety of our lives and on 11th May 2023 with security cover from Indian Army we headed to Imphal Airport for Guwahati.

With all this, I request that you take immediate action to investigate this matter and particularly apprehend the culprits involved in the looting and unauthorized occupancy of my house. I urge you to expedite the investigation and take the necessary steps to ensure the safety and security of my property.

Thank you for your prompt attention to this matter. I look forward to a swift resolution of this issue.
