Subject: FIR regarding the looting of movable properties worth over Rs.40,00,000/- (Rupees Forty Lakhs) by unknown miscreants/thieves from my house (Amazing Grace Mansion) situated on 2nd Street, New Lambulane, Imphal East, covered by Patta No. 1448, Dag No. 5453/5715 (Nongpok Ingkhol).

Sir,

I have the honour to report that whereas my family had been compelled to leave my house in Imphal, as above, during the last week of May, 2023 after the outbreak of the 'civil war' on May 3, 2023, and whereas the Central security forces were deployed/posted inside the New Lambulane locality, probably to protect the abandoned houses/properties, I have come to learn from a highly reliable source that almost all the movable properties inside my 4 storeyed building have been looted by unknown miscreants. The total value of the said properties, including cots, sofas, mattresses, blankets, clothings, airconditioners, kitchenwares, refrigerators, crockeries, washing machines, room heaters, ONE Tread Mill, One sports bi-cycle, hi-fi sound systems, jewelleryes, books and others will be approximately Rs.40,00,000/-. It is indeed very unfortunate that my house could be pillaged despite the presence/ posting of three to four units of Central paramilitary forces in the 1st, 2nd, and 3rd Streets of the locality.

Mention may be made here that whereas at the request of one Mr. James Kamei, Asst. Comdt. of CRPF, I gave my consent for the stationing of ONE platoon of his unit, thinking that their staying in my house would safeguard my house from being plundered, they were chased out by the Police (as reported to me earlier by Mr. Kamei).

It is also reliably learnt that my house has been occupied by armed militants since the past few weeks without any obstruction from the Central security forces there, nor from the Civil police.

May I, therefore, request you to kindly look into the matter and take up the case with Porompat Police Station, or the relevant higher authorities of the State Government and help me recover my looted properties **while also driving out those unauthorized occupants of my house.** A photocopy of my Patta, as above, is enclosed herewith for your kind perusal and necessary action.
