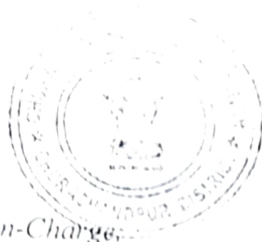

Subject: Report on crimes of unlawful displacement, looting & vandalism of household items, illegal possession of property and discrimination of Scheduled Tribes.

With references to the above cited subject, I have the honour to report to you as follows.

I a scheduled tribe belonging to the *Gangte Tribe*, which is a recognized tribe under the Constitution of India and a permanent resident of *1<sup>st</sup> Street, New Lambulane, P.O. & P.S.- Porompat & district- Imphal East, Manipur*.

That, due to the ethnic crisis that erupted in the State of Manipur between the Majority Meetei/ Meitei and the minority Kuki-Zo, we deserted our permanent & family resident which comprises of 4(Four) storied building (occupied by 4 Family households), leaving all our properties behind, to save ourselves from the Warmongers Meetei/Meitei populace on the *8<sup>th</sup> May, 2023* at around *10:30 AM*.

That, it came to my knowledge from a reliable source, that a mob of Meetei/Meiteis suspected to be members of Arambai Tenggol, Meira Paibis and the locals in and around the area have looted and vandalised all my household items/ movable assets on the *23<sup>rd</sup> day of Feb., 2024* at around *10:30 PM*.

That, I would also like to mention that, we gave the above mentioned resident on a rental basis belonging to a different community/tribe, while they were living peacefully in the said resident, a mob of Meetei/ Meitei suspected to be members of Arambai Tenggol & Meira Paibis have forcefully chased my Tenant away from the resident, and its believed that 3(Three) Family(households) are *unlawfully Occupying Illegal Possessing the said Property(Permanent Resident)*.

*That, it brings to my attention & concern that there might be an illegal activities being conducted at the above mentioned residence premises.*
