That, it came to my knowledge from a reliable source, that a mob of *Meetei/Meiteis* suspected to be members of *Arambai Tenggol, Meira Paibis* and the locals in and around the area have looted and vandalised all my household items/ movable assets on the **22<sup>nd</sup> day of Feb., 2024** at around **8:30 PM.**

That, I would also like to mention that, a mob of *Meetei/ Meitei* suspected to be members of *Arambai Tenggol & Meira Paibis* have forcefully broke into the said resident/ premises, and its believed that there are illegal Occupants living there *unlawfully Occupying/ Illegally Possessing the said Property.*

That, it brings to my attention & concern that there might be an illegal activities being conducted at the above mentioned residence/ premises.

That, it may also be report that the said criminal activities have cause grave mental agony and incurred huge lose which is estimated to be about **Rs.7,50,000/- (Rupees Seven Lakhs Fifty Thousand)** Only. inclusive of the my household items/ movable assets alone.

Therefore, I humbly pray you to kindly register a **ZERO FIR**, and book the perpetrators under the relevant laws of our Country. And for which act of kindness I shall always remain grateful to you. Thus, I am filing this application today.
