That I am resident of Sangai prou Maning Leikai, Imphal West and presently running a shop under the name and style "Advance Optometry Clinic" at Porompat Meri Leirak, Imphal East, Manipur.

That the above named two culprits are husband and wife and residents of the above stated place.

That today i.e. 2<sup>nd</sup> March 2024 at around 11:30 am, while I was in the said shop site, the above named culprits intruded into my said shop and started threatening in connection with an unsettled financial transaction between us and out of sudden the two culprits started again to assault on my body with fist blows, dragging hairs, cloths, kicking etc. throughout my body thereby causing pains, suffocation, etc. Not only the physical assault they attempted to kidnapped me in an autorickshaw brought by the culprit No. 2 (Husband) however due to the intervention of some of the passers by including my husband foiled their attempt to kidnapped me. That due to such mental and physical assault on my parts, I was brought to the hospital (JNIMS) immediately for medical treatment by family members.




