Deben of Singjamei Makha Shorokhaibam Leikai, Oinam Thingel, Imphal West District, Manipur at Khongman Manjil Mamang, Kongba Road, IE while he was walking As a result of which my brother sustained serious injury on his person and evacuated at Advance Hospital, Palace Compound Imphal for medical treatment but the doctor on duty declared brought death. It is therefore, requested to take necessary legal action against the culprit.
