Today i.e. 19/03/2024 at 7.30 pm received telephonic information that today at around 6.45 pm some unknown masked persons believed to be members of unlawful valley-based extremist groups entered the house of Irengbam Aken s/o (L.) Irengbam Maipak Singh of Bamon Kampu. They were wearing uniform similar to police uniform. They arrived in a white coloured Fortuner car which did not bear any number plate or any distinguishing features. The persons were armed with rifles and pistols. They talked to one Irengbam (0) Surbala, w/o Irengbam Aken Singh and one Kangabam Lemba (38) s/o K. Achouba of Bamon Kampu Makha Leikai who were present in the courtyard. They were questioning about the whereabouts of Irengam Robertson and Irengbam Aken. After searching the house, the masked men abruptly abducted Irengbam Surbala and Kangabam Lemba. The armed persons pushed Lemba and I. Surbala inside an Alto car (silver in colour bearing Reg. No. MN01G-0818), the owner which is K. Lemba. One of the armed persons drove the Alto car in the Northern direction where the road leads to Kongba. The Alto car was followed by the white colour Fortuner in which the accused persons had arrived in the house.

It was also reported that the same Fortuner car had come earlier at their residence in the morning the same day. At that time, they had talked to Irengbam Surbala and demanded a sum of money without which they were threatened with dire consequences.

Hence, a suo moto case under FIR No. 22(3)2024 IBG-PS u/s 364-A/34/506/419 IPC, 6 Official Secrets Act, 10 UA(P) Act & 25(1- C) A. Act has been registered for investigation.
