Subject:- Report.

Sir,

I the undersigned would like to state the following for favour of your kind consideration and taking up necessary legal action:-

1. That, on 30.12.2023 while performing the traditional Pao Haidokpa at the residence of one woman namely Yambem Melody Devi, D/o Yambem Deben Singh at Bamon Kampu Yambem Leikal, Imphal East, the family members and relatives/agents of the said woman had brutally beaten up the father of the complainant namely Laishram Dilen Singh of Lamboikhongnangkhong and his two companions namely Thokchom Thoubu Singh, aged about 46 years, S/o (L) Th. Iboton Singh and Thokchom Ingo Singh, aged about 65 years, both are residents of Bamon Kampu Mayai Leikal, Imphal East, Manipur.
2. That, it is pertinent to mention that the said woman was kept at the residence of Roshan Laishram, aged about 34 years, S/o Laishram Dilen Singh, of Lamboikhongnangkhong, Imphal West (brother of the complainant) without his consent by the family members of the said woman.
3. That, in good faith and as of normal customary practice and tradition of the Manipuri Meitei society, the elders of the complainant went to residence at around 9:30 A.M. of the said woman at Bamon Kampu for performing "Pao Haidokpa".
4. That, thereafter reaching the residence of the said woman, the elders of the complainant were illegally confined there at the said residence without any authority and abused them verbally by the family members and relatives/agents of the said woman.
5. That, in the evening at around 2:50 P. M. some family members demanded the presence of the complainants mother at the residence of the said woman which was communicated by the father of the complainant. And as such, the mother of the complainant namely Laishram (O) Kunjabi Devi and the complainant along with five other relatives namely Nongthombam (O) Naobi Devi, aged about 50 years, Laishram (N) Nanao Devi, aged about 45 years, Laishram (N) Priya Devi, aged about 38 years, Laishram (O) Radha Devi, aged about 41 years, all are residents of Naoremthong Laishram Leirak and some Meira Paibis of Lamboikhongnangkhong went to the said residence in a vehicle which was driven by a friend of the complainant.

As soon as they reached the said residence, the family members and relatives/agents of the said woman not only started abusing the mother and other four women verbally but also assaulted them physically without showing any respect of womanhood.

At that point in time, the complainant along with the van driver (a friend of the complainant) also saw some male members of the above mentioned woman approaching towards them by hurling stones at the vehicle but somehow both of them escaped the said place leaving behind his mother and other female relatives.



6. That, by taking undue advantage of the situation, the family members of the woman forcefully took the signatures of the complainants father on some agreements which was read aloud by a male person allegedly from amongst the family members of the said woman Yambem Melody Devi, "that on 3.1.2024 the brother of the complainant namely Roshan Laishram must be brought to the residence of the said woman and perform marriage between the said two individuals with the payment of Rs. 5,00,000/- (Rupees Five Lakh only) and after conclusion of the marriage, the said brother of the complainant shall leave for his residence without taking the said woman with him". And one Thokchom Kunjamani Singh from Bamon Kampu who happens to be the uncle of the complainant took the responsibility for complying the said agreements totally out of fear.
7. That, Nongthombam (O) Naobi Devi, aged about 50 years, Laishram (N) Nanao Devi, aged about 45 years, Laishram (N) Priya Devi, aged about 38 years and Laishram (O) Radha Devi were forced to lie down on the floor and started beating them up without any mercy by the relatives and family members of the said woman and amid this horrible moment, one of the male members of the family of the said woman even put his shoes and kicked on their faces disrespectfully. The mother of the complainant was also beaten and kicked on her face by a male member of the family of Yambem Melody Devi.
8. That, the complainant also filed a complaint to the Irilbung Police Station being G.D. Entry No. 12/ILB-PS/2022/Dt. 30/12/2023 requesting to rescue his family members from the illegal confinement/custody of the family members of the said Yambem Melody Devi.
9. That, the family members of the said woman also demanded to bring back the said woman to her residence from the residence of Roshan Laishram (brother of the complainant and have common residence) to which the complaint along with his friend (Van Driver) and 3 female elders brought the said Yambem Melody Devi back to Bamon kampu Yambem Leikai, Imphal East. The Complainant was also brutally beaten up by the family members and the relatives/agents of the said woman upon reaching the said residence at around 11:30 P.M. on the same day i.e. 30.12.2023.
10. That, the brother of the said woman also threatened the uncle of the complainant that "failing to comply with the agreements will result in destroying and firing of his residential house".

In the above facts and the circumstances, you are requested to kindly take up necessary legal action against the said culprits and punish them in accordance with law, in the interest of justice.
