Owi family have been residing at Kuki Village Phaiza, K. Nungmanbi. Since 3/5/2023, the situation became quite tense when news came about the clashes between Kukis & Meiteis in different parts of the State. Fearing of Owi lives, Owi family abandoned Owi house on the night of the same day (10:00) PM approx. i.e. 3/5/2023 and sheltered at Farm house of the above mentioned village and later shifted to Yambem High School Relief Camp, Andno, Imphal - East, Since 04/05/2023 till date.

Also it is learn that, on 5/5/2023, our house have burned down after looting all the house hold properties by the unknown groups of people and turned into ash.

This may be treated as OE for registration of FIR. Delay in lodging complaint is due to the prevailing Law & Order situation in Manipur. Complainant is presently sheltered at Yambem High School (Andno) relief camp.
