Sir,

I am the wife of Mr. Dangshawa Ringo, a permanent resident of Machi, PT - III, P.O. Pallel & PS Machi, Chandel District, Manipur temporarily residing at Namdunlong Village, Stadium Road, Imphal East, Manipur. That one Mr. Santa Bahadur, S/o Mr. Dil Bahadur R/o Khongjaron, Tamenglong, Manipur vide Deed of Simple Mortgage dated 10.10.2023 borrowed a total amount of Rs. 14,00,000/- (Rupees Fourteen Lakhs) only and mortgaged a landed property measuring about .315 Acre, Old Patta No. 21, New Patta No. 656/657, Dag No. 311/314, located at Phayeng Angom Mamang Leikai, Lamsang, Imphal West, Manipur.

When I, the undersigned, went to the house of Smt. Sanjina, D/o Mr. Santa Bahadur at Kongba Kshetri Leikai, Leirak No. 29, Imphal East, Manipur as the said Mr. Santa Bahadur was also staying with her to requests for payment of interests. Instead of paying the money, I was assaulted physically by the said Sanjina. My hairs were pulled out forcefully and I suffered tremendous pain on my head and other parts of my body. The incident took place at around 12:30 p.m. of 6/1/2024 at Kongba Kshetri Leikai. Besides, the above said mortgaged property is not genuine and the property in question stood mutated of someone else name. I could not report the matter in time as I was under medical treatment.

Therefore, you requested to kindly lodged FIR and initiate investigations against the said Smt. Sanjina and Mr. Santa Bahadur, the accused persons, in the interest of justice.
