1. That I filed a civil suit being original Suit No. 5 of 2018 in the Court of the civil Judge junior Division Imphal East District, Manipur as plaintiff against Yambem Ibochouba Singh S/o Late Y. Gourahari Singh of Bamon Kampu Khabam Leikai and another for eviction of the said Ibochouba Singh, his men, agents and privies from the suit land measuring .19 acre under patta No. 200,118(old)/226(new) covered by dag No. 256 situated at village No. 46, Bamon Kampu, Imphal East District Manipur.

2. The Hon'ble court after hearing the case passed an order dated 03/07/2019 for eviction of the said Ibochouba Singh, his men, agents and privies from the said land and the delivery of possession be made over to the plaintiff(me).

A copy of the said order and decree dated 03/07/2019 is enclosed herewith and marked as Annexure A/1.

3. That, I filed an execution case no. 1 of 2021 before the court of the Civil Judge junior Division Imphal East Manipur for execution of the order and decree dated 03/07/2019 (Annexure A/1). The Hon'ble court passed an order dated 25/7/2019 for eviction of the said Ibochouba Singh and his men, agents and privies from the said land and warrant for execution was issued to the Bailiff.

4. That on 30/8/2022 the Bailiff returned a report to the court that he has executed the court's order and the possession of the said land was handed over to the plaintiff (me). As such I have been possessing the suit land.
