

Information is received through various sources like social media (Facebook & WhatsApp) that Arambai Tengol numbering about 600 to 700 persons is conducting and undergoing Arambai Commando training at Manipur Athletic & Allied Sporting Institute (MAASI), Keirao Khunou which is about 1.5 Kilometer East from Irilbung Police Station. The Arambai Tengol group is involved in so many cases of PSs in Manipur including arms act, criminal intimidation, attempt to murder promoting enmity between communities etc. The recent viral videos in the social media also seen Arambai Tengol wearing Police Uniform and camouflage dresses which is unauthorized one.

Hence a case under FIR No. 14(3)2024 IBG-PS, U/S 400/503/307/153-A/416 IPC is registered suo-moto for investigation
