



Sir,

With due respect, I would like to make a report to your good office about Looting and Vandalism of all my properties including my Four wheeler vehicle VENUE 1.0 TRUBO IMT bearing Registratio No. MNO1 AW5445, the incident took place at new Checkon Tribal Market Imphal East, PS Porampat, District Imphal East on 5<sup>th</sup> May 2023 at around 4:25pm by a group of Meitei's and member of Arambai Tengol and Meeitei Leepun looted and Vandalized my household properties.

At the very outset, I would like to draw a few line for your information that, I had stayed as rented at New Checkon Tribal Market for morethen 8 years, the so called my home, Due to the state force sponsored ethnic conflict and well-armed Meitei mobs aided by State Forces and valley-based Radicalised Arambai Tengol and Meitei Leepun in illegal activities.

I could not make the said report on time due to present situation which unable me to do the report. This unlawful attacked put me and my family members 3 males and 2 females in grave danger. Therefore, we had presently taking shelter at Lower Chapllene, Hengtam Lamka Churachandpur, Churachandpur District, PS Churachandpur, Manipur.

Total worth of value destroyed Rs. 14,35000/- lakhs approx.  
I therefore seek your timely intervention and register FIR.
