



Subject: FIR on ransacked house and looted properties at my house and Clinic located at New Lambulane, Imphal East.

Sir,

I am to report that due to ethnic crisis in Manipur which erupted on 3<sup>rd</sup> May 2023, we have been taking shelters in Army Camp Mantripukhri, New Delhi and finally at Churachandpur. We have been hoping and eagerly waiting for normalcy to return so that we can go back to our house at New Lambulane, Imphal East.

However, from reliable sources it is learned that our building has been ransacked and all our properties have been looted by unknown miscreants on 15<sup>th</sup> January 2024 at around 7:00 PM

I would therefore request Police authority to kindly take necessary measures to protect further damage on our building and properties, and make necessary arrest and recoveries of the looted properties.

The list and rough estimated value of our land and properties is enclosed in a separate sheet herewith.
