



Sir,

I have the honour to report that my Alternative house located at 2nd Street, New Lambulane, near ECA Church bearing Old Land Patta No. 783/1884 and New Patta No. 974 in the name of Haokhotinlen Vaiphei was suddenly left behind along with all my household properties unattended due to a sudden violence erupted between Kuki and Meitei communities during the month of May, 2023.

That, on 25th February, 2024 I came to know through a reliable source that, my residential house was intruded by unknown Meitei miscreants during the 2nd week of February, 2024 and looted all my household properties by breaking the backdoor of my residential house. However, the exact date and time could not be ascertained.

It is therefore, requested to take up a legal necessary action as per the law of the land.
