

**Subject:-** An application for requesting your good office to register ZERO FIR.

Sir,

I the undersigned would like to report to your good office that on the 26<sup>th</sup> February 2024 (Monday) around 10:30 a.m around ten (10) of Meitei Miscreants suspected to be the Arambai Tenggol (wearing black T-shirts) were attacking our residence (Buildings) located at Pureiromba Khongnangkhong, Kom Leirak, Nongpok Ingkhol, Imphal East District, Manipur (CR/528, old patta no. 369, New patta No. 586/1937, Plot No. 5652/5675(A), Area: 0.017 (Point Zero one seven acre only) & Area: 0.019 (Point Zero one nine acre only) Class of Land : Homestead Land, Unit "B" Village No. 26(A)-Nongpok Ingkhol, Tehsil: Porompat, Imphal East.) Thereby threatening the occupants and looted all my properties of the Buildings including IBMC's Properties and locked the main entrance door. Later on, they (the occupants) were taken to Arambai Tenggol's Office, thereby threatening the occupants to vacate the above mentioned Houses. As per reliable source the above mentioned houses were occupied by the miscreants Arambai Tenngol. The Net worth of the looted properties including household properties like Kitchen items, electronic items, Furniture items, Books & Antiques etc may be around Rs. 35,93,000/- (Thirty-five lakhs & ninety-three thousand) in Rupees.

Therefore, I earnestly request your good office to kindly take necessary action as per the law of the land.
