



Subject :- An application file for lodging of FIR in Cognizance Order by the Supreme Court 25/09/2023 H.D. Order of the Governor of Manipur dated 10/10/2023 against the protection of my rented house at 2nd street, link road, New Lambulane, Imphal East District.

Sir,

With due respect, I the undersigned would like to request you for favour of initiation and necessary action on the above cited subject.

That, Sir, on account of the present ethnic communal war that flared up between Kuki and Meitei community from 3rd May, 2023 till date, the condition of staying at the valley became unsafe for life and we fled from Imphal by leaving our rented house on 4th May, 2023. We were shifted to 1st Manipur Rifles battalion at Imphal West. On 9th May, 2023 I along with my family members reached and took shelter as displaced person in one of my relative's house at Kangpokpi ward No. 15, Kangpokpi District.

That, ever since from 4th May, 2023 onwards, I could not learn about my things that were left and I could not made complaint to the police. However, after a lapse of 9 (nine) months I was informed by a reliable Muslim friend who is very intimate to me that my rented house was raided in the broad daylight of 26th February, 2024 by Meitei/Meetei miscreants robbed and ransacked my room and robbed off my bed, fridge, furniture, household properties etc which worth is about Rs. 19,92,000/- (Rupees nineteen lakhs ninety-two thousand) only and on 27th February, 2024 I was again informed that my rented house was occupied by the unknown miscreants.

As such, it is my appeal to your good office to look and take initiative for the end of justice.
