





Subject : Filing of report on unlawful displacement, vandalism, looting and loss of personal household goods placed at rented residential premises in Imphal

Madam/Sir,

On the subject cited above, I write to bring to your kind notice the following:

- I. that I, the undersigned, belong to Paite tribe which is a recognized tribe in the state of Manipur.
- II. that I am an employee of SIDBI, the apex Bank for MSMEs in India, which is under the administrative control of Department of Financial Services, Govt. of India.
- III. that, I was transferred from our Mumbai office to Imphal office in April 2023 to take charge as the In-charge of our Branch/State office and had accordingly rented a premises at the apartment of Mr. Hentinseh Chongloi (mob. 8131051645), located at 2nd Floor, V.L. Inn, Link Road 1, 3rd Street, New Lambulane, Near Tribal Market, Imphal - 795 005.
- IV. that, upon taking possession of the rented premises in the last week of April 2023, I had purchased and placed various household goods in brand new condition besides my personal items, complete list of which is placed as **Annexure**.
- V. that, due to the large scale discrimination of tribal populace commencing from the 3rd of May, 2023, the undersigned ran for life and had left entire belongings in the rented premises, save and except what was worn on body at the time and could not take possession every since.
- VI. that, it has come from reliable source on February 24, 2024 that the rented premises had been vandalized and all goods had been stolen by unidentified miscreants, in utter defiance of all existing laws and law enforcement agencies.

I, therefore, I request that **ZERO FIR** be registered against all perpetrators of this illegal act and be brought to book as per the law of the land.
