

Sir,

With due respect, I have the honour to report the following few lines for your kind consideration and necessary action.

That on 29th February 2024, miscreants from Meitei community forced open the locked gate of my residence at New Lambulane 2nd street, New Checkon, Imphal East, Manipur 795001 and looted all my belongings and they are making a home without my consent. As per information received, the said people have since been staying in my house illegally. My residence which I mentioned has been remained unoccupied by me as I no longer can stay in Imphal since May 3 as the Meitei community has FORCEFULLY driven us out threatening to kill us.

The approximate value of loss of property is estimated to be about Rs.30,00,000/- (thirty lakhs).

I could not report the incident to the concern Police Station due to prevailing law and order situation of the state.

I therefore request your good office to kindly take necessary action in this regard.
