

Sir,

With due respect, I would like to state the following for your kind information and necessary action -

That, due to the ongoing conflict in the state, I am compelled to leave my house with my family at New Lambulane on 10<sup>th</sup> May, 2023.

That, on the 21<sup>st</sup> February 2024 I received an information from a reliable source that the properties (belongings) I have left behind (listed as under) were all looted and plundered by unknown miscreants. It is suspected that the looting, plundering of properties and illegally occupied my house having New Patta No. 1018, S/No. C/R 603 and Dak No. 5448/5581 of 26(A) Nongpokp Ingkhon, Imphal East by unknown family in between the 30<sup>th</sup> of January 2024 to 20<sup>th</sup> February 2024.

In this regard, I would like to request your good office to take up necessary action so that I can be compensated, the culprits be caught and exemplary punishment be meted upon them.
