



With due respect, I would like to state the following for your kind information and necessary action -

That, due to the ongoing conflict in the state, I am compelled to leave my house with my family at New Lambulane on 10th May, 2023.

That, on the 21st February 2024 I received an information from a reliable source that the properties (belongings) I have left behind (listed as under) were all looted and plundered by unknown miscreants. It is suspected that the looting, plundering of properties and illegally occupied my house having Patta No. 1018/1970, S.No. C/R -603/604 and Dag No.5448/5581-A at New Lambulane First Street, Near Tribal Market Complex, Imphal East in between the 30th January 2024 to 20th February 2024.

In this regard, I would like to request your good office to take up necessary action so that I can be compensated, the culprits be caught and exemplary punishment be meted upon them.
