Sir.

With due respect, I the undersigned would like to request you for favour of initation and necessary action on the above cited subject.

That, sir I and my family had narrowly escaped the sudden onslaught of ethnic communal war of 3<sup>rd</sup> May 2023 the following day ie. 4/5/2023 with life threatening on the way. Latter on that night, we were taken to 2<sup>rd</sup> M.R and on 8<sup>th</sup> May,2023 we were shifted to Motbung. Kangpokpi and given shelter as displaced person.

That, on the 23<sup>rd</sup> of Feb 2024, I have been informed by reliable sources on the illegal occupation of my house by valley miscreants and womenfolk. To add to our woes, picture of house in New Lambulane with letters U and AT and their unit numbers boldly written in the gates were widely circulated in social media. However the exact date and time could not be ascertained but suspected to be the 2<sup>nd</sup> week of Feb. 2024

That, we have been robbed off every furniture and kitchen and household appliances—3 beds, teak sofa set, dressing table, Godrej Almirah, wooden Almirah, Computer desk, dining table set, a gold necklace, 3 traditional Thadou Kuki necklace costing 30 to 40k each, I very expensive traditional gong (dahpi), 32 traditional sarong each valued at 4k to 7k, 20 traditional shawls each valued at 1.5k to 2.5k, Videocon fridge, a microwave oven, I sony TV 55 inch, LG washing machine, VAIO SE 14 laptop, HP Printer, several water syntax, water pump, 5 gas cylinder etc, all items amounting to about Rs,25,00000 (Twenty five lakhs) only.

That, a Maruti Car bearing Regn No.MN01S4630 (Silver) (Rs. 1, 50, 000/-lakhs). Chassis No. SB308IN1809687, Engine No. 2512279 is registered in the name of my brother-in-law Mr. Haoginlun Hangshing is missing from my residence.

That, the total estimated loss is about Rs, 26,50,000/- (Twenty six lakhs fifty thousand) only. This is excluding price of land property and cost of one storey building construction.

Therefore, it is my appeal to your good office, to kindly takes strong initiative in protecting my house and property from further theft and damage.
