Sir,

With due respect, I the undersigned have the honour to state that today i.e. 27/03/2024, a specific input regarding concealment of arms and ammunitions in the foothills west to Pangei was received at 2.30 pm of the same day and accordingly, a search operation was planned. A combine team consisting of CDO Imphal East, 6 IRB and a column of 4 AR was organized and the same team launched a joint operation in the said area at 3.00 pm of the day leading to significant recovery of arms and ammunitions.

The following arms and ammunitions were found concealed at a place in foothills of the eastern side of Heingang hills (western side of the Pangei Nepali village) Imphal East District and the same were seized at 4.10 pm following due procedure.
