P7A6FFN1134890 on the roadside of the Royal Gym. My vehicle was stolen away by some unknown miscreants. On checking the CCTV footage installed at the nearby house. It was observed that 3(three) unknown miscreants driving a Honda Activa had stolen the vehicle. The approximate value of the vehicle is about Rs. 3,60,000/ (Rupees three lakh and sixty thousand) only.
