

I have the honour to report that, yesterday i.e. 15/2/2024 at about 10:30 pm, some unknown persons fired 1(one) round at the dwelling house of my younger brother namely Md. Sakir Ahmad (31) S/O (L) Md. Taher Ali of Urup Khunou Mayai Leikai from the paddy field of Urup Khunou Mayai Leikai . In that the G.I sheet of the wall of my younger brother's dwelling house got partly damaged. The act of the unknown persons seems to attempt the life of my younger brother and his family members. But my younger brother is out of station during the time of incident. He was posted at Manipur Bhavan , New Delhi since 23<sup>rd</sup> August, 2023

It is therefore requested you kindly to arrest the unknown persons and taken necessary legal action according to law.
