With due respect, I have the honour to state that my vehicle Tata Truck-1109 bearing Regd. No. UP22T-6796 driven by driver Mr. Indrajit Singh aged about 40 yrs. s/o. Lt. Ibomcha Singh of Kakching Khunou Umathel, P.S.- Waikhong, Kakching District, Manipur laden with 312 (Three Hundred & Twelve) Haryana quality rice bags for FCI, Manipur Imphal have been sent from Jiribam for Imphal on 28/11/2023 in convoy along NH-37 to drop at Sangaibrou Godown, Imphal West in good faith. That, on his way to Imphal and in between Makru Bridge to Kambiron Barrak Bridge, the driver mentioned above had sold 53 (Fifty Three) Nos. of rice bags to unknown persons without my knowledge and permission and later fled away after abandoning the vehicle with the remaining rice bags at Kambiron near Barrak Bridge (exact date & time not known). This fact I came to know after informing me by the Drivers Union, Manipur, Imphal on 01/12/2023.

I therefore, request you to kindly book the above mentioned driver immediately and punish him under befitting punishment as per law of the land.
