Today i.e. 19/03/2024 a public consultative meeting was convened at Mandap Hall, LM (Lungchong Meiphai) Block Headquarter, Ukhru District, Manipur under the aegis of the Youths of Western Tangkhul Region in relation to the upcoming MP election. In the said meeting, an intending candidate of Outer Manipur parliamentary constituency Shri. Alfred Khanngam Arthur along with other dignitaries were present. In order to thwart any untoward incident, adequate security of both state police forces and central security forces were deployed in and around the place of the meeting. In the midst of the meeting, at around 12:30 p.m. of the same day, several rounds of gunshot from automatic rifles were heard firing from a safe distance on the northern side of the place of function. The security personnel reacted swiftly and responded to the firing with retaliatory firings while the other security personnel took the VIP at a safe and secured place. There was no human casualty and no destruction of properties. Soon, the security personnel organised themselves and conducted extensive search operation in order to apprehend the unknown miscreants. However, the miscreants escaped taking advantage of the thick jungle. Further search is on in collaboration with central security forces. In the interest and demand of the public who came and participated in the meeting from different villages, the meeting resumed and completed under the watchful eyes of the security forces.

It is highly suspected that the unprovoked firing was committed by the NSCN-IM cadres not targeting human casualty but in order to intimidate Shri. Alfred Khanngam Arthur so as to abstain him from his candidature for the MP election.

Base on the incident, a Suo-Moto case under FIR No. 01(03)2024/LM-PS **U/S.** 400/506/171-C/34 IPC & 25 (1-C) A. Act is registered for investigation.
