Sir,.

I, the undersigned, have the honour to state the following facts and circumstances for your kind information and necessary prompt action to investigate and arrest the accused person as under:

1. That complainant is the legally wedded wife of the Accused Tuiyorin Raihing of Paorei Village, Ukhrul District, Manipur. But, due to offensive nature and continuous physical and mental harassment committed by the accused person, complainant at present compel to stay separately with the accused.

2. That the accused person is a habitual drunkard and habitually abuser, causing physical and mental harassment to the complainant and Children, and due to his habitual habit he was admitted to rehab center at Imphal in the year 2023 for a period of 6 months.

3. That the accused person habitually committed cruelty and uses criminal force, assault, thereby causes hurt to his children's and causes grievous hurts in many occasions to the complainant, by using sticks and with his bare hands, recently the accused try to commit murder by using sharp weapons knife, with respect to this facts, complainant is ready to produce many prosecution witnesses and medical proof to support the prosecution/complaint case. Thus, due to continuous cruelty act, criminal force, assault and theft committed by the accused person, complainant has no other option but file the present complaint before the competent police station to take up necessary legal proceeding and to prosecute the accused **under section 307, 354, 356 and 498A of the Indian Penal Code.**

Further, for the welfare of the complaint minor children and other adult children, and for the safety of the complainant, the undersigned hereby filed this present complaint to arrest and prosecute the accused in the interest of Justice.

4. That the accused person in many occasions stole many house hold items like gas cylinder, cooking materials, furniture, cloths etc. within the complaint dwelling

house, parental house and neighboring houses. Recently, local community of Greenland, Ukhrul District, Manipur apprehended the accused person and accordingly punished with a fine of Rs. 2000 (Rupees Two Thousands) only for committing theft. Copy of order issued by Greenland, Ukhrul District, Manipur is annexed hereunder.

May I therefore, request you to kindly take necessary action and arrest the same for necessary legal proceedings for the ends of Justice.

In the light of the aforesaid facts and circumstances, may I therefore, request to your goodself to kindly initiate befitting necessary action and legal proceeding against the accused person for various offences committed by the accused person under the various Section of Indian Penal Code as mentioned in the subject.

For which act of your kind favour and necessary action, I shall remain grateful.
