Sir,

With due respect I have the honor to report that as per order NO A-114/SP-KPI/ (W.A.B) dtd 20/01/2020, today, the 25th February 2021 (i.e. 25/02/2021) at about 2.00 P.M., a combined team of Kangpokpi District Police led by Addl. SP (2/0) KPI along with DSP G.S.P.M., SDO Tuzangvaichang, representative from N.A. Imphal, Forest Dept. and officers & personnel of Kangpokpi District Police numbering around 60 persons under the supervision of Shri. AG Singit, IPS SP-KPI carried out destruction of illicit poppy plant cultivation. The combined team destroyed about 30 Acres each of the poppy cultivated plants at T. Khonomphei village site and Mahui Arhang village site respectively. The approximate value of the destroyed poppy plants is estimated to be about Rs 4,50,00,000/- (Rupees four crores and fifty lakhs) only.

It is therefore requested kindly to take up further necessary legal action as per provision of law.
