Today, i.e 4/3/2021 at about 10:10 AM received a reliable information that on 3/3/2021 at about 8:00 pm one trailer truck bearing Regn. No. NL01G-3485 driven by unknown coming from Imphal for Dimapur and one Bolero Pick up bearing Regn. No. MN03-0380 driven by unknown coming from opposite direction dashed against each other at S. Golai near Changoubung village along NH-2 due to rash and negligent driving on the parts of both the drivers of vehicles. As a result, 2 occupants of the above Bolero pick up including the driver sustained injuries on their persons and were evacuated to hospital for medical treatment and the vehicle also got badly damaged.

Hence, a suo-motu case under FIR NO. 12(3)2021 KPI-PS u/s 279/338/427 IPC has been registered for investigation.
