With due respect i have the honour to state that as per order no B-1/18/SP-KPI/18 (NAB)/140 dated 11/01/2021, a combine team of Kangpokpi District Police led by Addl. SP(Ops) KPI, DSP Hq KPI, Officers and personnels numbering about 70 persons, NAB Imphal, NCB Imphal ,SDC-KPI, Forest Department Kangpokpi under the supervision of Shri P.G Singsit, IPS SP Kangpokpi carried out destruction of illicit opium poppy plant cultivation in the Hill Ranges of Haijang Village, Kangpokpi District, Manipur on 22/01/2021. The combine team destroyed about 45 acres of the cultivated poppy plant. The approximate value of the destroyed poppy plant is estimated to be about Rs.2,10,00,000 (Two crore and ten lakh only).

It is therefore requested kindly to take up further necessary legal action as per provision of law.
