SP(LO) KPI, DSP (G.SPM), Officers and personnels numbering about 70 persons, NAB Imphal, NCB Imphal ,SDC-KPI, Forest Department Kangpokpi under the supervision of Shri P.G Singsit, IPS SP Kangpokpi carried out destruction of illicit opium poppy plant cultivation in the Hill Ranges of Harup Naga Villages, Kangpokpi District, Manipur on 27/01/2021. The combine team destroyed about 20 acres of the cultivated poppy plant. The approximate value of the destroyed poppy plant is estimated to be about Rs.1,50,00,000 (one crore fifty laks only).
