SUBJECT - LODGING OF FIR

1. Generic inputs on a Non SoO group TPLA trying to revive from a long time was being received from the past few weeks from various own sources at general area Keithelmanbi Military Colony. In addition, inputs of extortion demands from various sources were also received for last one month. On 06 Feb 2021, a specific input from own source was received at 2245 hrs on 06 Feb 2021 regarding presence of TPLA cadres at Gen A Ward No 2 of Keithelmanbi Military Colony, who were involved in multiple extortions as well as threatening of villagers in and around Keithelmanbi. Based on this input a team from COB KPI was launched at around 2300h on 06 Feb 2021.
2. The party reached the suspected house at around 2320 hrs and cordoned it. On detailed search of the house, it was found that only one indl named Mr Nekholal Tuboi @ Naathon was present in the house. The individual was taken into custody at 2440 hrs and on detailed search of the room where he was staying, a country made pistol with two live rounds were recovered from his room along with other items. On spot questioning he revealed that the pistol which was recovered was not his but his associates named Brutly and Frenly who was staying along with him but has managed to escape before our party has reached the location. Based on his input, the search for his two associates was carried out in the general area in and around Keithelmanbi till 0400 hrs, however they could not be found.
3. The individual is a resident of Bongmol village and has been actively involved with TPLA from the last few weeks. As per complaints received from locals, he had given extortion calls as well as threats to chiefs of Champhai area namely. Bongmol, Khaouchangbung and Keithelmanbi.
4. The details of the individual are:-

 - (d) 01 x Cellecor Mobile Phone with Airtel SIM card No. 9612406812
IMEI No. 1 355259514567331, IMEI No. 2 355259514567349
 - (e) 01 x Torch Light
6. The individual was then taken to the District Hospital, Kangpokpi for the medical examination and Rapid Antigen Test for COVID 19. The individual along with recovered items are being handed over to KPI Police Station for further investigation. It is requested that the individual may please be booked under relevant acts of IPC for being part of a non SoO group as well as for processing fire arms illegally.
