Sub: Complaint report.

Sir,

Based on intelligence input received from own sources it was revealed that one individual Seiminlun Chongloi (27) S/o Tongkholal Chongloi r/o village Chalwa, Sels Finance secretary of KRA, Saikul Batallion was present in village Chalwa and was engaged in extortion and tax collection along the IT Road along with his associates. On 17 Feb 2021 at 2000 hrs own source revealed that Seiminlun along with two of his associates is extorting and collecting tax at village Chalwa. Based on this input a small team from COB Gelnel launched an operation. The above mentioned individual was caught red handed at Chalwa village bus stand at 0200 hrs on 18 Feb 2021. However his associates managed to flee from the spot. On further interrogation the indl admitted his identity and one mobile Redmii alongwith Jio sim card B/Regd no. 6009473479 and IMEI B/Regd no 867473049742449 and 867473049742456 was recovered.
