Today i.e. 21/3/2021 at 2:00 Pm, received a reliable information that on the same day at around 1:45 PM one passenger tourist bus bearing registration No. A5C1UC-3699 coming from Imphal towards Guwahati driven by Unknown driver collides with one loaded tata truck bearing registration No. WB25G-0867 driven by unknown coming from Dimapur towards Imphal at near Kangpukpi Bridge along NH-2 due to rash and negligent of both the drivers in which 8 passengers of the bus alongwith both the drivers of the vehicles injured on their persons and immediately evacuated to CRC-KPI for medical treatment and both the vehicles got badly damaged.

Hence a Suc-Motu case has been registered under FIR NO. 14(3)2021 KPI-PS U/S 279/338/319/427 IPC for investigation.
