at around 8:30 pm a crowded mob numbering about 200 to 300 persons of Kangpokpi District block National Highway 2 at Kangpokpi Bazar Traffic Point in support of 36 hours bandh called by CSO-Kangpokpi which caused obstruction for movement/plying of vehicles along Nh-2. Meanwhile, ASI Paotinkai of KPI-PS along with police team on duty while proceeding towards SP-KPI Office on Police Vehicle 407 Mini Truck was attacked at Kangpokpi Bazar Traffic Point by unknown miscreants suspected to be bandh volunteers of 36 hrs bandh called by CSO-KPI by pelting stones and using catapult(slingshots) in which one police personnel namely C/no. 1805304 Lettinlal Baite got minor injury on his person and the police vehicle got partly damaged.Police personnel on duty under the supervision of Shri P.G.Singsit IPS, SP-KPI fired several rounds of tear gas, smoke bombs, stunt grenades etc. in the presence of Shri. T.Shyamkumar Singh, SDC(HQ)/EM, DC's Office, KPI who was on magisterial duty. Thus, the crowd were dispersed.

In this regard, a suo-motu case has been registered under FIR No. 15(4)2021 KPI-PS 283/341/431/503 IPC & 8b NH Act,1956 for investigation.
