**SUB : SUSPECTED WY TABLETS AND HEROINE SEIZED**

1. On 18 Apr 2021 at 0400 hrs, an input was received by COB KPI about a drug deal being carried out by some Moreh based drug racket at a Jhoom hut in general area Bimparao. Considering the same a surveillance party was tasked to keep surveillance on the suspected Jhoom hut where the deal was taking place.
2. At about 0530 hrs own surveillance party passed the info a deal is underway in the Jhoom hut which was spotted earlier. On receiving this info, the party which was on standby was launched from COB KPI and reached the location by 0545 hrs. Seeing the security forces the peddlers as well as the other party panicked and left behind the consignment and fled from the location in a white Creta. The party followed the peddlers for a while; however they managed to slip away. On searching the area an entire consignment of drugs was recovered. The area was searched in detail and the operation was called off after the recovery of the consignment. On the initial assessment it was found out that the consignment contained a huge amount of suspected WY tablets and suspected Heroine.
3. On detailed assessment of the recovery it was found that it consisted of 34 soap cases which contained an orange powder covered inside a white plastic cover suspected to be Heroine, when weighed the entire stuff the total weight came around 440 gms. (excluding the soap cases) Along with this 3 packets covered with yellow plastic cover was also present. On opening these plastic covers, it contained small blue packets in which suspected WY tablets were found. On further counting a total of 138 such small blue packets were found. Each such blue packet contained varied quantities of suspected WY tablets. On proper counting it was found that the total quantity was 23,594.
4. The summary of the items recovered from the consignment is as mentioned below:-
  - (a) Suspected WY Tablets – 23,594 Nos (138 Blue packets)
  - (b) Suspected Heroine – 440 gms

The recovered items are being handed over to KPI PS for your further necessary action please.
