Today the 23rd April 2021 at 4:30 PM received a reliable information that on the same day at about 4:25 PM one loaded Tata Truck bearing registration No. MH12-MV 5802 driven by unknown driver coming from Senapati side and proceeding towards Imphal and one TVS Scooter without registration number ridden by unknown with 2 pillion riders coming from the same direction were collided each other while the scooterist was trying to overtake the above loaded truck at Changoubung Village near the waiting shed on NH-2 due to rash and negligent driving on the part of the driver of the Tata truck and the rider of the scooter. As a result, the unknown scooterist with the 2(two) unknown pillion riders sustained serious injuries on their persons and were evacuated to the hospital for medical treatment however one of them succumbed to his injuries on the way to JNIMS Hospital, Porompat, Imphal and both the Tata Truck and the scooter got badly damaged.

Hence, a suo-motu case under FIR No. 19(4)2021 KPI-PS u/s 279/304-A/338/427 IPC has been registered for investigation.
