Subject- Request for registering of FIR regarding 2(two) seized timber truckload

Sir,

In inviting a reference to the above cited subject, I am to inform you that 44 Assam Rifles seized 2(two) truckload of Timber at Gelnel and handed over to Kangpokpi Forest Range Office on 25th April, 2021 at around 4:23pm. After handing over on the same day i.e. 25th April 2021 at about 6:30pm while the forest officials were trying to transport the seized truckload timber to the safe custody, some unknown miscreant forcefully entered the forest office complex and snatch and took away the truckload timbers. In the incident our forest staff tried to control the situation but on the contrary, the unknown miscreants manhandled our forest staff and threatened for stopping them.

So, i'm requesting you to kindly take necessary action and register a FIR. In this regard, Also, the complaint could not be made on time while seeking advice from higher authority.
