Subject: Request your good office to lodge FIR against Major Alok Sathe AR "E" Company, Post Commander of Gelnel Village (Banglabung) who is accused of murdering Mangboilal Lhouvum (29) S/o Sehlam Lhouvum of Chalwa Village on 4th June 2021 at around 9PM.

Sir,

I the undersigned would like to lodge FIR against Major Alok Sathe, 44 AR "E" Company, Post Commander of Gelnel village (Banglabung) that the accused officer along with his jawan Rifleman Mr.Amar and two others in civil dresses using civil vehicle (Tata Yodha) with service weapon carried out operation at Chalwa village on 4th June 2021 at around 9PM wherein the victim(Late) Mangboilal Lhouvum was first treated with Alcohol and brought onto the road side and lethally fired upon. The areas people said that he always roamed freely with his service weapon with civil dresses and collect information for his own benefits for a month.

After the victims was critically injured, he was carried to PHC T.Waichong village since no good medical facility was there the doctor referred him to Kangpokpi District Hospital for further treatment . Unfortunately, He Succumbed to his injuries and expired before reaching Kangpokpi District Hospital.

An army officer in civil clothes out on a mission in a civil vehicle appears to us to be a premeditate act and we firmly believe that the murder of Mr.Mangboilal Lhouvum is also premeditate.

Mangboilal Lhouvum works as a helper of Shaktiman Driver and is a father of 4 children who lives at Chalwa Village.
