REQUEST FOR LODGING OF FIR ,

1. On 04 June 2021 troops from COB Gelnel opened fire in self defence at village Chalwa. KRA eadres has caught hold of one jawan and put pistol in his mouth. In this firing incident one individual succumbed to his injuries and second individual even after being hurt escaped from the incident site along with other two armed eadres of KRA group. Withvested interest a misinformation campaign was initiated by the local youth of Chalwa village. They mobilised crowd to surround the security post at gelnel viliage. The gang leaders took Law in own hands and put two vehicles earrying soldiers on bonafide military duty on fire. With intend to put life of soldiers in danger the instigators tried to surround the vehicles on fire, they did not allowed troops to escape from the burning vehicles. The troops had to leave the vehicles to save their lives, leaving behind their weapon, ammunition and protective gear. The identity of the instigators who had put the lives of troops on bonafide military duty in grave danger can be established from the social media video clips on youtube. The community, leaders instead of negotiating for peaceful protest, through hatred speeches provouged public to charge on troops putting lives of troops in grave danger.
