Today, the 24th August 2021 at 12:30 pm received reliable information that on the same day at about 7:00 am while one Maruti Van B/Regn. No. MN01K-9601 driven by unknown carrying local fish for sale at Senapati coming from Imphal side broke down suddenly on NH-2 just near the Kangpokpi Police Station and was repairing the vehicle, in the mean time 2 unknown miscreants coming on a bike abducted the driver and owner of the local fish to a nearby hotel and demanded a sum of Rs. 5,000/- (Five Thousand) only by way of extortion. On receipt of the above information, enquired into the matter and ascertained the above information to be true but the unknown miscreants were not found there. Immediately, a Police team of Kangpokpi Station led by the undersigned under the supervision of SP Kangpokpi Karthik Malladi, IPS and Addl. SP(I/O) KPI Thangkhochoh Haokip launched an operation and finally managed to arrest 2 (two) unknown miscreants near the Shikander Barber Shop at Kangpokpi Bazaar on the same day at about 12:50 PM. Later the arrested unknown 2 (two) miscreants and later identified themselves as (1) Kaikhohao Kipgen @ John (36) S/o (L) Jangkholam Kipgen of J. Songtun Village, Kangpokpi District and (2) Ngamgouthang Sitlhou @ Jacob@Hemon (27) S/o Seijangul Sitlhou of Wakotphai Village, Kangpokpi District A/P Kangpokpi W/No.4 both are cadres of KNF(P) (SoO Signatory group). On interrogation, they also admitted the charge levelled against them. On spot body search the following articles viz. 1) 1(one) Nokia Phone alongwith Airtel Simcard B/NO. 8730940256, were recovered from the possession of Kaikhohao Kipgen and 1) mi redmi 6A Phone along with JIO Simcard B/No. 6009018185. 2) RC Smart Card of bike bearing Regn. No. MN01Z 2760 3) One Yamaha YZFR-15 bearing Regn. No. MN01Z 2760 4) One Black Purse 5) Indian Currency Rs. 40/- (Forty Rupees) only were recovered from the possession of Ngamgouthang Sitlhou.

Hence, a suo-motu case under FIR No. 26(8)2021 KPI-PS U/S 400/364-A/384/120-B IPC has been registered for investigation.
