I have the honour to state that today, the 29th August 2021 at about 7:30 pm, we 9th IRB (Sports team) stationed at Kalapahar O.P. led by me Inspt. H. Manglemba Meeteei, Post Commander, Kalapahar-O.P. and Inspt. Henminthang Kipgen OC-KPI-PS, SI. Rex Haotinlal Doungel and Police party were carrying out frisking and checking of vehicles along NH-2 and happen to come across a Maruti Swift (Magna Grey in colour) B/Regn. No. A/F which comes in a suspicious manner coming from Senapati side towards Imphal. The combined teams apprehended the said Car near Teijang veng, Waiting-shed Keithelmanbi. On searching the vehicle, 3(three) packets of suspected opium (3-KGs approx.) sealed in a brown plastic were found under the Driver seat. Accordingly the driver of the car was arrested with the seized articles along with the vehicle. The driver identified himself as Ramesh Basnet (34) S/o Amar Bahadur Basnet of Kalapahar. After observing all formalities the seized articles and the arrested person was handed over to KPI-PS for further necessary action.
