Subject: A criminal complaint against the undernoted accused persons for their criminal acts of physical assault, threat and intimidation to the complainant on 07.09.2021 at about 2 p.m at Khopi Village, Irang Part-II, Kangpokpi, Manipur

Sir,

With due respect, I, the undersigned complainant, have the honour to report that I am a Media Reporter of Association of Gorkha Artists, Manipur (AGAM) TV, based at Kanglatongbi under the jurisdiction of Sekmai Police Station, Imphal West, Manipur which is the only Manipuri Gorkha TV Channel in the present State of Manipur based at Kanglatongbi under the jurisdiction of Sekmai Police Station

That I was called by the members of Development Committee, MGNREGS of Khopi Village and Gorkha Harup to give media coverage of the proceedings of election of new office bearers on 07-09-2021. Accordingly, I along with my Cameraman, namely, Mahesh Thapa of Koirengei went to Irang Part-II and covered the proceedings of Harup Village suddenly the people who had gathered there for participating in the electoral process, started shouting and formed their groups/ unruly mobs. Thereafter, one group attacked and physically assaulted the other group with sticks etc and clash took place in an uncontrollable manner but the fight ended after sometime.

That thereafter, I along with my cameraman were returning home, but suddenly on the way, I and the cameraman were waylaid and attacked and physically assaulted with use of dangerous weapons and sticks without provocation and cause by the undernoted accused persons who have been later identified. I received multiple physical injuries all over my body due to the assault and use of force, but my cameraman managed to escape unhurt. I was told by the said accused persons not to come again or dare to cover and report the incident. However, a section of people helped and managed to protect me and thus I could escape from the spot.

Thereafter, on the same day at about 4 p.m., I went to Kangpokpi Christian Hospital, Kangpokpi and got examined of my injuries and took X-ray and other medical test as advised by the attending doctor and I was discharged from there with medical prescriptions.

It is pertinent to mention that media being the fourth pillar of democracy and such attack on media is attack on democracy which is condemnable by one and all in the strongest term.

In view of the above facts and circumstances, you are requested to take up necessary legal action against the undernoted accused persons for their criminal acts of physical assault, intimidation, threat and book them under law at the earliest.
