No. 3800389 Hav. Nar Bahadur Lohar of Phulbari, PO- Madhuri Pathar, Dhemaji District, Assam, AR personnel met a self accident at Kalapahar Village along NH-2 in which 5 (five) personnel including the driver who were in the said BP Vehicle got injury on their persons and immediately evacuated to Assam Rifles Medical Hospital,IGAR South, Mantripukhri for medical treatment. However the driver namely Hav.No. 3800389 Nar Bahadur Lohar of Phulbari, PO- Madhuri Pathar, Dhemaji District, Assam succumbed to his injury and the doctor on duty declared him brought death.
